

# Security Index

## Costs for security services

### Introduction

SBIX Svenska Branschindex has produced a Security Index on behalf of the Swedish Security Industry Association. The purpose of the index is to measure changes in the costs of security services. The Security Index can be used as a basis and support for adjusting prices in different types of agreements.

### Index design

The Security Index is a fixed basis. The base time is set to October 2008. From June 2016 and forward, the values are updated four times per year (January, April, June and October). Previously, the index was updated twice a year (in April and October).

A fixed base index measures price changes compared with the base time.

The Security Index is also factor cost index, that is, an input index. Input is defined here as the production factors that are included in security services.
